### **JUDGEMENT**

Plaintiff Mr.Lalremthanga S/o Salhnuna R/o Salem Bethel veng, Aizawl is present through Ld. Counsel Shri H.Lalchhuanawma who is appointed as a Legal Aid Counsel for the Plaintiff.

Defendants State of Mizoram through the Chief Secretary to the Government of Mizoram & 4 others are present through Ld. Asst. Govt. Advocates- Shri R.K.Malsawmkima & Shri Joseph Lalfakawma.

Today is fixed for preliminary hearing on maintainability of the suit for further proceeding.

The instant suit has been filed by the Plaintiff Mr.Lalremthanga for compensation as damages in his favour against the Defendants (State of Mizoram) amounting to Rs.18,00,000/- (Rupees eighteen lakhs) only alongwith interest @ 12 % per annum until full realization of the amount and to show cause as to why the prayer of the Plaintiff shall not be allowed as prayed for or in the alternative pass an order (or orders) may be passed in the interest of justice and fair play.

Accordingly, the instant Civil Suit No. 10 of 2012 stands dismissed without cost.
