On hearing both sides and on careful perusal of the records available at hand, this court is of the opinion to grant permission to the plaintiff to withdraw his case with a liberty as prayed for to file a fresh suit on the same cause of action as per law.

Accordingly, the Civil Suit No.82/2011 stands withdrawn with liberty to file a fresh suit on the same cause of action.

With this order, the petition CMA No.21/2012 A/o C.S.No.82/2011 stands disposed of.
