Ld. Counsels for the plaintiff Shri L.H.Lianhrima and others present.

The present suit is filed by the plaintiff for payment of compensation amounting to Rs.2,16,000/- (Rupees two lakhs sixteen thousand) only alongwith interest @ 18 % per annum from the date of damaged of water canal of plantation of cash crops till realization of the said compensation and also to make immediate payment of Rs.20,00,000/- as loss of income for deprivation of their right to use their land and Rs.1,00,000/- for mental suffering and agony etc. The present suit has been filed against the three defendants.

LS. Counsel for the plaintiff orally prayed this court to allow him to withdraw the present suit and may also be granted liberty to file the same in future.

Heard the defendants counsel who have no objection to the prayer of the ld. Counsel for plaintiff.

Considered both submissions.

This court is of the confirmed opinion to grant the prayer of the plaintiff's counsel as prayed for.

Accordingly, the plaintiff is allowed to withdraw the present suit and is granted liberty to file the same afresh in future as prescribed by law and within time.

Hence the present suit stands withdrawn and thus disposed of.
