Ld. Counsel for the plaintiff Shri L.R.Tluanga Sailo & Ors, Advocates present.

Today is fixed for submission of examination-in-chief on affidavit of plaintiff's witness.

The plaintiff filed the instant suit under Order XXXIV of the Code of Civil Procedure 1908 for foreclosure of the mortgaged property covered by LSC No.104-201/01/90 of 2003 belonging to the Defendant no.1 for the recovery of the outstanding amount of loan of Rs.5,02,952/- with interest @ 13% per annum w.e.f. April 2011 till full realization.

Ld. Counsel for the plaintiff Bank (Mizoram Rural Bank, New Market Branch, Aizawl) submitted that the defendant Smt. Lalbiakliani Sailo has repaid all the outstanding amount of the loan recently to the plaintiff Bank and thus the loan dues has been liquidated. Ld.
