**ORDER**

The present suit T.S.No.8 of 2007 had been instituted by the plaintiff Shri V.L.Tawna on 04.04.2007 for declaration of title over the entire area of land covered by LSC No.Azl-41 67 of 1986 and Azl-4166 of 1986 and for setting aside the order issued vide Memo No.T.15016/16/88-DISP/DTE(REV) dated Aizawl the, 9<sup>th</sup> January, 2003 and for declaring the LSCs in the names of the plaintiffs be valid and proper and also issue permanent injunction against the defendants, restraining them from issuing any other detrimental to the interest of the plaintiff and restraining the defendants especially the defendants No.5 to 9 from interfering with the peaceful possession of land by the plaintiffs and for consequential reliefs.
