**JUDGEMENT**

**23.5.2012**

Counsels for the plaintiff are present. The counsels for the Defendant no.1 and the Defendants no.2&3 are also present.

The counsels for the plaintiff submitted that the present suit was valued at Rs.2,00,000/- only therefore as per the provisions of the Mizoram Civil Court Act,2005 this court did not have the pecuniary jurisdiction to adjudicate the suit and only the court of Civil Judge Junior had the jurisdiction to entertain and dispose the present suit. He further submitted that another suit regarding the same subject that another suit regarding the same subject matter, which was registered as Title Suit No.8/2007, was pending disposal before the court of Gracy L.Bawitlung, Civil Judge, Aizawl and present suit may kindly be endorsed to her court for necessary disposal.

The counsels for the Defendant no.1 and the Defendant no.2&3 also supported the prayer made by the P/L.

Heard and considered. Para No.12 of the plaint shows that the suit is valued at Rs.2,00,000/- by the plaintiff, therefore it is clear that the suit is triable by the Civil Judge Junior. Accordingly it appears that the court does not have the pecuniary jurisdiction to entertain the suit.

The suit is referred to the Hon'ble District Judge, Aizawl for fresh endorsement to the court having the pecuniary jurisdiction to entertain and dispose the suit.
