ORDER

Plaintiff is present through ld. Counsels Smt.Lalthlamuani and Shri Zochhuana. AGAs present.

Defendants No.1&2 absent till today without step in spite of summons issues to them.

Received back a copy of summons issued by this court to defendant no.2 Lalmuanpuia, Venghlui, Aizawl unserved due to obstruction of its service by the said defendant.

On the back of the copy of the said summons, the serving constable namely Shri Suraj Lal Bania wrote down that the said defendants no.2 had torn apart the first summon copy in front of the serving constable. The defendant, at the time of second summons refused to receive the second summons and thus returned the said summons unserved.

The Officer-in-charge of Aizawl Police Station requested this court in writing to issue a Non-bailable Warrant of Arrest against the defendant No.2 (Lalmuanpuia, contractor).

Ld. Counsel Smt. Lalthlamuani prayed this court to issue a Bailable Warrant of Arrest against both the defendant No.1 & 2 to force their appearance in court as they are the necessary parties who both failed to appear in court till date.

The issuance of summons to the said defendant would mean to enable this court to know as to whether the said defendants deny or admit the suit against them for further proceeding.

I have considered the submissions of the ld. Counsels for the plaintiff. This court is of the opinion to issue bailable warrant of Arrest against the defendant No.1 & 2 as the first step.

Issue Warrant of Arrest against the defendant No.1&2 who are to be produced before this court on 23.05.2012 at 11:00 AM.

Give copy of this order to the Officer-in-Charge, Aizawl police station and counsels for the plaintiff for necessary action.
