**ORDER**

Neither the plaintiff nor the Defendants are present.

The instant Money Suit had been instituted long back in the year 2003 by the Mizoram Rural Bank Ltd. Durtlang Branch through its Manager against F.Roluahpuia, R/o Ramthar veng, Aizawl & 2 others for foreclosure and sale of mortgaged landed properties covered by LSC No.Azl.4191 of 1986 belonging to Defendant No.2 and or for recovery of Rs.7,36,160/- as on 31.03.2003 with interest @ 18.25% per annum with effect 01.04.2003 from the defendants.

The instant case, though instituted in the year 2003 is now only at a stage of framing of issues. The case has been lingering on for such a period as the parties casually prosecuted the case.

As the plaintiff failed to appear in court for a number of times, this court has informed the plaintiff Bank to take step for further proceeding. However, the plaintiff still failed to take necessary steps, this court has no other option but to pass an order of dismissal as per the provision of order IX, Rule 3 of CPC 1908 as neither party appeared till date.

Accordingly, the instant suit stands dismissed as per the provision of Order-IX, Rule 3 of CPC 1908.
