## ORDER

Received case record from the Superintendent of Police Serchhip. Today is fixed for hearing the bail application Lalremtluanga Advocate is appointed as counsel for accused petition at states expense. Addl. PP is also present.

The ld. counsel for accused petitioner submitted that 218 days has lapsed since arrest and remand of accused petitioner in connection with Serchhip P.S Case No.66/2014 dated 16.11.2014, U/S 376(2)(i) IPC r/w section 4 of POCSO.

The ld counsel submitted that statutory period for filing charge sheet has already expired and it is the statutory right of the accused petitioner to be released on bail u/s 167(a)(i) Cr P.C.

Also heard the Addl. P.P who frankly admitted that ninety days has already lapsed and charge sheet has not been filed.

On perusal of record it is found that ninety days has already lapsed since arrest and first remand and charge sheet is not filed till date.

Hence, I am constraint to consider the case of the accused petitioner and allow bail application.

Accused Laltlanmawia may be released on bail on furnishing a bond of Rs.30,000/- with one reliable surety of like amount duly certified by the Local Council concerned, Aizawl and the surety must be a permanent resident of Aizawl, holder of EPIC and the surety should also produce photo copy of EPIC and 2 copies of Passport size photo.

With the above order bail application stands allowed and disposed of. Give copy of this order to all concern.
