The Ld.Counsel for the accused person submitted that the accused person was arrested on 1.3ss.2015 at around 7:00 pm at Bawngkawn, Aizawl by the Excise Personnel on the alleged possession of 4 grams of suspected to be heroin. He further submitted that the S/A suspected to be heroin is only 4 grams which is bailable offence under ND & PS Act. And further submitted that the accused person is a woman and is having special privileges under the Code of Criminal

Procedure Court and also was arrested at night around 7:00 pm which is the violation of the provision laid down under Cr.P.C. And also submitted that the accused person is suffering from asthma. As such the Ld.Counsel for the accused person earnestly prays the Court to release her on bail.

Also heard the Ld. A.P.P who does not make any object as the charge section levelled against the accused is bailable one.

After hearing both sides and on perusal of the available material on the case record I am of the opinion that there is no ground to reject the instant bail application. Bail is allowed with the following conditions:

- 1. The accused must attend the Court regularly.
- 2. She must not hamper nor tamper the investigation of the case.
- 3. She shall not repeat the same alleged offence during the bail period.
- 4. Bail bond is Rs 10,000/- with reliable surety of the like amount and must be a permanent resident of Aizawl certified by Local Council Chairman/Secretary of the area.

With the above order the bail application is disposed of.
