**ORDER**

Accused/convicted Malsawmkima is produced before me on the strength of production warrant. Today is fixed for hearing Mr.Lalramthlenga Advocate, Id counsel for the convicted person, submitted that the trial court did not complied 207 Cr PC, and 304 Cr PC, the Id counsel also submitted Medical certificate issued by Health & Medical Officer district Jail Certifying that accused Malsawmkima was suffering from severe scabies infestation since August 2015 and also diagnosed with Tinea corporis with supreme posed infection all over trunk, leg, grains and hand and had been put under isolation in jail(due to stigma) and advice to take treatment outside jail as soon as possible, the counsel also submitted letter of compromise from his father, who is also complainant in the instance case, and prayed the court to release by setting off the detention period.

I also heard Addl. PP who raise objection stating the pain is about to heal and no need to release him at this stage. Upon hearing of both parties, and on physical body verification of accused Malsawmkima in the court, I am convinced by the submission of Id. counsel for the accused as well as personal hearing of accused.

The conviction and sentenced awarded by Chief Judicial Magistrate Aizawl u/s 506 IPC is upheld, but modifying the detention period from one year to the period already undergone, and to pay a fine of Rs.500/- id 5 days S.I.

The revision petition is disposed.
