**ORDER**

Accused Malsawmtluanga on bail is absent with step. In the meantime, seen Death Certificate issued by Registrar of Birth & Death Seling, sl.no.142136 Reg no.8 of dt.20.12.2015 certifying that accused Malsawmtluanga S/o C.Thansiamma mother name Duhkimi was died on 15.12.2015 at Seling, and the death certificate was delivered to the deceased family on 20.12.2015. Also seen letter from Shri R.Lalnunthara, President, Village council/court Seling Aizawl

District stating that accused Malsawmtluanga was resident of Seling and witnessed the death of accused Malsawmtluanga in the month of December 2015.

I have no doubt that accused Malsawmtluanga was expired/died as certificate was issued by two competent authority certifying the dead of accused. I find no reason to proceed the case further against the accused Malsawmtluanga. On the other hand, if fake certificate is issued by the Registrar of Birth and Death, Seling in order to save accused from charge leveled against him u/s 376 IPC, the two competent authority will responsible on the matter.

Hence Bawngkawn P.S Case No.148/2013 dt.28.8.2013 Registered in this court under session case No.117/2013 u/s 376(2)(i)/506IPC is hereby closed, and dismissed fore with.
