### JUDGMENT & ORDER

#### NUCLEUS OF THE CASE

This is a Suit for recovery of Rs. 18,28,072/- (Rupees eighteen lakhs, twenty eight thousand and seventy two) with pendente lite interest at the rate of 12% per annum till realization filed by Mr. M.C. Vanlalawia against Smt. Lalthai & Ors. The defendants also file written statements, whilst the suit is at the proceedings of evidence stage, parties by executing Deed of Agreement Dt. 9<sup>th</sup> June, 2011 reached compromise of the suit which reads as- "Both defendants paid Rs. 6,00,000/- (Rupees six lakhs) to the plaintiff on 9/6/2011 through learned counsel and also received in full by the plaintiff. It is further covenanted that the defendants shall paid another sum of Rs. 6,00,000/- (Rupees six lakhs) to the plaintiff before lapse of July, 2011". Parties with their respective learned counsels also subscribed their signatures in the said Deed of Agreement.

### ORDER

Being a compromise proceedings, the defendants are directed to pay the sum of Rs. 6,00,000/- (Rupees six lakhs) to the plaintiff before lapse of July, 2011.

With the above, the case shall stand disposed of accordingly.
