ORDER

This application has been filed u/s 24 r/w Section 151 CPC for transfer of the Civil Suit No.41/2009 which is pending before the Court of Pi M. Lallianmawii, Senior Civil Judge, Aizawl to any other Court of Senior Civil Judge due to urgency of the case and the ailment of the Presiding Judge.

Mr. A. Rinliana Malhotra, ld. Counsel for the Applicant submitted that there is urgency in the Suit which is at the stage of Further Proceeding. The ld. Counsel submitted that due to the illness of the Presiding Judge, the Court has not been functioning properly and the same has caused a lot of problems to the parties. The ld. Counsel further submitted that in the interest of justice and for early redress of Page 2 of 2

the grieavance of their Plaintiff, the Suit may be transferred to any other Court of

Senior Civil Judge.

The ld. Counsel for the Respondent did not raise Objection and admitted that

due to the ailment of the Presiding Judge, the matter has not been attended for a

application has been made only because of the illness of the Presiding Judge who

Cancer patient and often has to avail Leave for her treatment. Considering the

reason stated in the application and in the interest of justice, I find that sufficient

ground has been made to transferred the said Suit.

Accordingly, Civil Suit No. 41/2009 shall be transferred to the Court of

Senior Civil Judge-I, Aizawl i.e. Pu Lalbiakzama. The parties shall appear before

the said Court on 19.5.2014.

With the above Order, the application stands disposed off.
