## **ORDER**

Received the Case Record of Declaratory Suit No. 11 of 2014 on being endorsed by the ld. District Judge for disposal.

Upon perusal of the Plaint along with its enclosures, it is noticed that the Suit is for Declaration to the effect that the Defendants are liable to accept and process the application of the Plaintiff for availing Loan for Tyres Re-Treading Industry/Unit Centre under the Credit Guarantee Fund Scheme for Micro and Small Enterprises.

Depending on the prayer made in the plaint, the Suit has been registered as Declaratory Suit. At paragraph 13 of the plaint, the Suit has been valued at Rs. 41.70 lakhs. Section 13 of the Mizoram Civil Courts Act, 2005 priovides that the Court of District Judge shall be deemed to be the Principal Civil Court of Original Jurisdiction within the local limits of its jurisdiction. Section 14 of the said Act provides that the jurisdiction of the Court of Senior Civil Judge shall extend to all Original Suits and proceediongs of civil nature the value of the subject matter of which exceed Rs. 2 lakhs or such other sum as the High Court may from time to time specify. Section 21 of the said Act provides that the CPC shall be followed in spirit in all the Civil Courts. Section 17 of the Act provides

that an Appeal shall lie to be the Court of the District Judge when the subject matter of the Original Suit is less than Rs. 5 lakhs.

Section 15 CPC provides that every Suit shall be instituted in the Court of the lowest grade competant to try it.

Considering the provisions of the Mizoram Civil Courts Act as well as Section 15 CPC, this Court not being the lowest grade competant to try the Suit, let the matter be placed before the ld. District Judge for re-consideration.
