## ORDER

- 1. The application has been filed under Section 5 of the Limitation Act for condoning delay of 545 days in filing connected Review Petition No. 2 of 2015 against the Judgment & Award dated 30.9.2013 passed by Smt. Helen Dawngliani, learned Addl. District Judge, Aizawl in L.A. Case No. 9 of 2013.
- 2. I heard the learned Counsels Ms. Cicily Lanunfeli and Ms. Lianmawii Hauhnar appearing for the applicants. I also heard the learned Counsel Shri Ali Hussain for the N.F. Railway Opposite Parties.
- 3. No written objection was submitted on behalf of the O.P. Nos. 1 & 2 and none appeared on their behalf at the time of hearing the application.
- 4. The case of the applicants is that the copy of Judgment & Award dated 30.9.2013 was received from their earlier counsels very late. Apart from that they were not informed by their earlier counsels that the Judgment & Award did not include land value. According to the learned Counsels appearing for the applicants, the delay of filing the connected review was caused due to the negligence of their earlier Counsels since their records file was misplaced by their earlier counsels for about a year and thereafter, the applicants approached another advocate who kept their record file for about five months without pursuing the matter. The learned Counsels submitted that the delay was caused due to the unavoidable circumstances which were beyond the control of the applicants. The learned Counsels also submitted that they took time in collecting the necessary files and documents and also took time for preparation of connected review petition. According to the learned Counsels Ms. Cicily Lalnunfeli and Ms. Lianmawii Hauhnar, they will be deprived from claiming entitlement of compensation in respect of their lands valuation if their joint application for condoning delay of 545 days is not allowed.

- 5. On the other hand, the Railway O.P. made objection to the submission of the applicants that the delay of filing the connected review petition was willfully caused by their counsels. It is the submission of the learned Counsel for the Railway O.P. that their learned counsels failed to claim land value before the Reference Court in L.A. Case No. 9 of 2013. According to the learned Counsel, the applicants were satisfied with the solatium and the interest passed by the Reference Court. Hence, the learned Counsel Shri Ali Hussain pressed to dismiss the application for condoning delay of 545 days in filing the connected the review application.
- The learned Counsels Ms. Cicily Lalnunfeli and Ms. Lianmawii Hauhnar appearing for the applicants submitted that the applicants' explanation of delay does not smack of mala-fides. They placed the Hon'ble Apex Court's decision in N.Balakhrishna v. M.Krishnamurthi AIR 1998 SC 3222 at Paragraph 13 that 'It must be remembered that in every case of delay, there can be some lapse on the part of the litigant concerned. That alone is not enough to turn down his plea and to shut the door against him. If the explanation does not smack of mala-fides or it is not put forth as dilatory strategy, the Court must show utmost consideration to the suitor.......'
- 7. Upon hearing the rival parties and perusing their pleadings, I find that there is a sufficient ground for condoning delay of 545 days in preferring application for review of the judgment and award dt. 30.9.2013 in L.A.Case No. 9 of 2013. Accordingly, the instant petition is allowed. However, the Review Petition will be decided on merit.
- 8. The misc. application is disposed off.
