ORDER

Case record put up on call.

Ld. Counsel for the decree holders Sh. Lalramhluna is present. Ld. Addl. GA Smt. Rose Mary for the defendants is also present.

The Id. Counsel for the decree holders submitted that this court vide its Judgement and Award dt.14.6.2013 passed an order for payment of interest and solatium to 157 Nos. of decree holders in this case. He further submitted that after examining the case, there was an overlapping of claims with other cases, and as a result, another order dt.22.1.2015 was issued with a direction to the District Collector, Mamit to submit cheque for payment of compensation to 96 Nos. of decree holders out of 157 decree holders in this case vide order dt.22.1.2015 passed by this Court whose claims were not found overlapping with other cases. He also submitted that the District Collector, Mamit vide its letter No. L.11012/1(F)/2015-DC(M)/Pt dt.9.4.2015 submitted cheque for payment of compensation to 77 Nos. of decree holders mentioning that cheques for 15 Nos. of decree holders had been withheld for the reason stated therein subject to the order of this Court. On receipt of the said cheque, the award compensation for 77 Nos. of decree holders were disbursed and almost completed and prayed the court to issue a direction to the District Collector, Mamit to submit cheque for payment of compensation to 15 Nos. of decree holders whose compensation money were withheld.

The Id. Addl. GA Smt. Rose Mary for the District Collector, Mamit raised no objection to the prayer of the Id. Counsel for the decree holders stating that the case is at the stage of execution.

On careful perusal of the facts and circumstances of the case and on the complaints made by the 15 Nos. of decree holders, I hold that there is no sufficient reason to withhold

the award compensation money of 15 Nos. of decree holders and the District Collector, Mamit is hereby directed to submit an open cheque in the name of Peshkar to this court within a period of two weeks from the date of this order for payment of compensation to the following 15 Nos. of decree holders:-
