### **ORDER**

1. The brief facts of the case are that the applications for reference to Court were filed before the respondent/District Collector. It is shown in the applications made before the District Collector that the petitioners are not satisfied with the land value assessment and the measurement of their lands acquired for the purpose of widening and development of approach road to 400 K.V. Sub-Station. The District Collector referred the matter to the learned District Judge for adjudication in respect of the Award 10 of 2012.

2. The learned Counsel Smt. Lalthlamuani appearing for the petitioners, the learned Counsel Shri R.Lalremruata for the District Collector and the learned Counsel Shri Ali Hussain for the Power Grid Corporation were heard.

3. In short, the learned Counsel Smt. Lalthlamuani prays for joint verification and re-measurement of the lands of petitioners which was not strongly objected by the learned Counsels appearing for respondents.

4. It is therefore ordered that the District Collector, Aizawl shall conduct a joint verification and re-measure the lands acquired in the presence of the petitioners and the Chief Manager, Power Grid Corporation and submit report to this Court on or before 31.8.2015 positively.

5. The interlocutory application is disposed off.
