ORDER

1. The application has been filed u/s 151 of CPC for releasing solatium and interest to the petitioner.

2. The learned Counsel Ms. N. Lalzawmliani appearing for the petitioner, the learned Addl. GA Shri R. Lalremruata for the District Collector, Aizawl and the learned Addl. GA Shri Joseph Lalfakawma for the Respondents No2-4 were heard.

3. Upon perusing the record in LA Case No. 33/2014, this Court directs the Respondent No.1/District Collector, Aizawl to release 30% solatium and 12% interest per annum for the compensation awarded under Draft Award No. 2 of 2014 to the petitioner.

4. The Id. Counsel Ms. N. Lalzawmliani informs this Court that the solatium and interest awarded by this Court is already deposited to the District Collector, Aizawl which is also accepted by the Id. Addl. GA Shri R. Lalremruata appearing for the District Collector, Aizawl.

5. Hence, the District Collector, Aizawl is directed to release the solatium and interest to the petitioner within a period of 1 week from the date of receipt of this Order.

6. The interlocutory application is disposed off.
