O R D E R

1. The application has been filed on behalf of the applicants to give direction to the respondent to make assessment in their favour.

2. According to the learned Counsels appearing for the applicants, in the Judgment and Award dated 27.3.2011 passed in connection with L.A. Case No. 8 of 2012 by the learned Additional District Judge, the applicants were awarded solatium and interest with interest at the rate of 6% per annum to be calculated from the date of 10.8.2012 till realization.

3. Per Contra, the learned Addl. GA Rose Mary appearing on behalf the OP/District Collector, Mamit filed a written objection. In the written objection filed by her, the amount of compensation had already been paid to the applicants and no amount is payable to the applicants. To support her stand, the learned Addl. GA also filed copy of the Actual Payee Receipts of the applicants.

4. The amount of compensation having been satisfied as has been stated by OP/District Collector, Mamit, the present Interlocutory Application filed, therefore stands dismissed. However, the applicants are given liberty to file in the Civil Court, if they feel aggrieved.

5. Hence, the Interlocutory Application is disposed off.
