ORDER

The application filed on behalf of the State is fixed for hearing today.

2. In the application, the Case I.O. made a prayer to this Court to accept the supplementary charge sheet as part and parcel of Aizawl P.S. Case No. 21 of 2015 dated 9.1.2015 under Sections 302/449 of IPC. The reason of filing the supplementary charge sheet is that the addition of Shri Rosangzuala, the Jr. Scientific Officer, Photo Division of FSL, Aizawl as prosecution witnesses and the copies of the photographs annexed to the supplementary charge sheet as evidences in the instant case inasmuch as the proposed prosecution witness visited the crime scene jointly with the police and took snap of the crime scene.

3. On the other hand, the learned Defence Counsel Shri S.L. Thansanga strongly made objection.

4. After hearing the rival parties, I find that the supplementary charge sheet and its annexed documents can be treated as part and parcel of Aizawl P.S. Case No. 21 of 2015 dated 9.1.2015 under Sections 302/449 of IPC.

5. It is ordered that the supplementary charge sheet and its annexed documents is treated as part and parcel of Aizawl P.S. Case No. 21 of 2015 dated 9.1.2015 under Sections 302/449 of IPC. In the result, Shri Rosangzuala, the Jr. Scientific Officer, Photo Division of FSL, Aizawl is added as prosecution witness and the copies of the photographs annexed to the supplementary charge sheet shall be proved for evidences in the instant case.
