On hearing the submission of the rival parties, I find justified to release accused Vanlalnghaka on bail on his furnishing a bail bond of Rs. 10,000/- with one reliable surety of the like amount. The surety shall be a permanent resident of Aizawl city having a Voter's ID.

This Court has imposed the following conditions: -

- a) that he shall attend the Court regularly,
- b) that he shall not commit an offence similar to the offence of which he is accused, or suspected, of the commission of which he is suspected, and
- c) that he shall not directly or indirectly make any inducement, threat or promise to any person acquainted with the facts of the case so as to dissuade him from disclosing such facts to the Court or to any Police Officer or tamper with the evidence.

Failing which the Bail Order shall entail cancellation.

The petition is disposed off.
