**ORDER**

Accused persons Lalropuia Famhoite, Norbar Sinate, Ngurthantluanga, Lalchualova, Reuben Lalromawia, H. Lallawmkhup @ H. Lala and Lalbiakliana are produced from judicial custody. Ld. Addl. PP and Id. Defence Counsels Sh. R. Laltanpuia for accused 1-3 and Sh. H. Laltanpuia for accused 4-7 are also present.

I have perused the records and found that the accused persons namely, (1) Thangsiam S/o Lalngaisanga of Vairengte Field Veng (2) Thangrosum @ Menga of Chandikhal, Cachar (3) David of Rengkai, Cemetery Road, Manipur (4) Vanlalnghaka of Rengkai, Zote Veng (5) Ngurthangliana @ Lalngurpuia C/o Hluna of Phuaibuang (6) Lallawma of Parvachawm, Manipur (7) Lalrohluia of Parbung, Manipur (8) Lalrawngbawla of Parvachawm, Manipur (9) Vanlaldika of Chandikhal, Cachar and (10) Ngamlanvel @ Sharma of Parvachawm were not arrested in connection with the present case. It is shown from the records that the Case IO did not follow the procedure prescribed under

Chapter VI-C of the Criminal Procedure. Hence, in view of the Judgment dated 2.4.2014 passed in Crl. Pet. No. 226/2014 by the Hon'ble Mr. Justice B.D. Agarwal, the present case is transferred to the Id. Sessions Judge, Aizawl for sending back to the Id. Chief Judicial Magistrate.

Accused persons are remanded back to judicial custody till 17.5.2016.
