ORDER (ORAL)

The application filed under Section 439 of Cr PC is disposed off today after hearing the rival parties.

The petitioners' case is that they were arrested by Police on 29.9.2016 in connection with the charge under Section 302/34 of IPC. The contention raised on behalf of the accused is that there is no prima facie case against them U/s 302 IPC.

The Id. Counsel Shri S.L. Thansanga has made a prayer to release the petitioners on bail on the ground that all the witnesses except the Case I.O. have already been examined by this Court. He further submits that release of the petitioners will not hamper the ongoing trial.
