ORDER (ORAL)

The application filed by the petitioner under Section 438 of Cr PC for seeking pre-arrest bail is disposed off today.

- 2. The learned Counsel Shri Jonathan Lalrintluanga submits that the petitioner is innocent. According to him, the petitioner has reason to belief that he may be arrested on accusation of having committed a non-bailable offence since he was called to the Police Station. Hence, the ld. Counsel seeks pre-arrest bail for the petitioner.
- 3. On the other hand, the Addl. PP Smt. Lilyparmawii Hmar for the State did not press the Court to reject the application.

- 4. I have given my consideration to the submission made by the learned Counsels for the parties. I do not find any reason why Anticipatory Bail Application filed by the petitioner will not be allowed. Hence, the Anticipatory Bail Application is allowed to the petitioner with the following conditions-
 - (i) a condition that the petitioner shall make himself available for interrogation by the Case I.O. as and when required;
 - (ii) a condition that he shall not, directly or indirectly, make any inducement, threat or promise to any person acquainted with the facts of the case so as to dissuade him from disclosing such facts to the Case I.O.;
 - (iii) a condition that he shall not leave Mizoram without prior permission of the Case I.O.
