The application filed by the petitioner under Section 438 of Cr PC for seeking pre-arrest bail is disposed off today.

- 2. In the instant case, the petitioner is booked under section 407 of IPC. The brief case of the petitioner is that some articles having value of Rs. 2,74,415.84/- were dispatched to the complainant by M/S H.K. Logistics (In short "Transportation Company"). But, the articles were not received by the complainant. According to the complainant, the petitioner had committed breach of trust.
- 3. The Case I.O. SI Dhyan Singh Minhas appeared before me.

4. The learned Counsel Shri R. Lalhmingmawia submitted that the

petitioner is innocent. According to him, the petitioner filed FIR against a staff of HK

Logistic, but the FIR was not entertained by the Officer-in-Charge, Aizawl Police

Station. He also submitted that SI Deepak Pathak is not the Case I.O. in the instant

case.

5. On the other hand, the ld. Addl. PP Smt. Lilyparmawii Hmar for the

State submitted that there is a clear case in the instant case. Hence, the State

Counsel made a strong prayer to refuse Bail.

6. I have given due consideration to the submission made by the learned

Counsels for the parties. I do not find any reason why Anticipatory Bail Application

filed by the petitioner will not be allowed. Accordingly, Anticipatory Bail Application is

allowed.
