

MINUTES OF MEETING OF FINANCIAL EVALUATION COMMITTEE FOR INSTALLATION OF CCTV SURVEILLANCE SYSTEMS IN DISTRICT COURTS UNDER AIZAWL JUDICIAL DISTRICT ON 17.11.2017 AT 2:30PM IN THE OFFICE CHAMBER OF THE ADDL. DISTRICT & SESSIONS JUDGE, DISTRICT COURT, AIZAWL

After the Chairman welcomed members of the Committee, financial bids of the three firms - David Marketing, RS Traders and Zone Security who were technically qualified as per report of the Technical Evaluation Committee was opened and evaluated.

The prices quoted by each firm for supply, installation, testing and commissioning of CCTV surveillance systems inclusive of tax and 2 years warranty are as follows:

3.	David Marketing	15,85,100	L3 price

There is a calculation error in price of 24" LED Monitor in respect of David Marketing. The unit price obtained by adding Basic Price (Rs.10156.25) and Taxes (Rs.2843.75) is quoted as Rs.3900 while it should be Rs.13000. Hence, the total price of 8 numbers of 24" LED Monitor is corrected from Rs.31200 to Rs.104000 and consequently, the total amount quoted is corrected from Rs.15,12,300 to Rs.15,85,100.

Similarly, the unit price of 12V SMPS in respect of Zone Security is corrected from Rs.1984 to Rs.1964 and the total amount quoted is corrected from Rs.11,68,468 to Rs.11,68,138.

As per the quotation terms and conditions, the selection of the bidders will be based on Quality cum Cost Based Selection (QCBS) methodology i.e. scores of the technical bid (70% weightage) and Commercial/Financial bid (30% weightage) will be made. The bidder with the highest Total Score/Combined Technical & Financial Score (CTFS) will be declared as L1 bidder.


The Total Score/Combined Technical & Financial Score (CTFS) with weightage 70:30 is


$$\text{TOTAL SCORE} = \text{TS} \times (70 \div 100) + \text{CS} \times (30 \div 100)$$


The rate quoted by each firms and the total score obtained by them are as shown in the table below :-

1.	David Marketing	15,85,100	95	67.23	86.67	L1
2.	Zone Security	11,68,148	75	91.23	79.87	L2
3.	RS Traders	10,65,810	70	100	79	L3


Based on the combined score i.e. technical score and financial score, David Marketing obtained the highest score and thus was declared as the L1 bidder.
