ORDER

No. **B.12011/1/2020-D&SJ(A)/13** : In continuation of the Order issued vide this Office letter of even No. dt.24.03.2020 following the directions issued by the Hon'ble Gauhati High Court in Order No. 19 dated 24th March, 2020 vide Memo No. No.HC.III-06/2020/845-855/G dt.24.05.2020, and in continuation of Office Order vide Memo No.B.14015/1/2020-D & SJ (A)/1, dated Aizawl the 23rd March 2020, the functioning of the District Court, Aizawl Judicial District, shall remain restricted with effect from 16.04.2020 till 03.05.2020 and only cases of extreme urgency involving liberty shall be taken up. The following Judicial Officers will be on duty during the period mentioned against their respective names for video conferencing with UTPs on date fixed for appearance and first production of offenders. The hearing of such cases, including remand matters related to fresh arrest and extension of remand, shall be taken up by the following Judicial Officers unless otherwise ordered by the Hon'ble Gauhati High Court:

In order to restrict the necessity of attending Court by the Judicial Officers on their respective dates of duty, it is proposed to amalgamate the remand dates as far as feasible to particular dates altogether, for a period of 14 days in compliance to Section 167 Cr.P.C. In case of first production, if any, the particular Judicial Magistrate/Nodal Officers on duty for the particular date may be contacted over mobile phone for further necessary steps.

The Ld. CJMs at Champhai, Kolasib, Serchhip and Mamit are directed to make similar arrangement in their respective jurisdictions.

Matters which are already fixed for listing and hearing upto 03.05.2020 shall stand deferred unless extreme urgency is shown for the immediate hearing of the matter.


